Where is the Justice? JACQUARIUS "JAY" QUINN May 4, 1999–November 6, 2016

Jacquarius "Jay" Quinn was a bright, kind and loving young man who cared deeply for his family and friends. He was his grandmother's right-hand man and loved her beyond words. He loved animals, he loved to draw, and he could often be seen palling around with his little brother, Jamelian. He was a fun-loving boy in his senior year of high school with a beautiful smile. Life was good, until his innocent life was suddenly snuffed out for no reason at all. He had no criminal history and no gang affiliation.

Younger brother, Jamelian was featured on local TV during a January 19, 2019 interview regarding his brother, Jacquarius' unsolved homicide. He was just 10 years-old then, when he painfully fought through his tears while talking about his older brother; describing him as the best brother anyone could have and missing him so much. This was a little over two years later, and the devastation and heartache of Jacquarius' senseless loss was and still is to this day, ever present.

A Few Words From Jan

As 2019 is fast rolling to a close (or maybe as you read this, 2020 has already begun), I am sharing with you some 2019 thoughts.

Certainly, for me it feels like the days have run through my fingers like grains of sand. Each one different, yet never able to grasp onto one to enjoy like I would have liked. It has all passed so quickly, for me more quickly than ever before. A year with many challenges and, at times, not even sure if the challenges were met with success. However, as I reflect, I realize there were also many blessings to be thankful for. I believe we must focus on the blessings and put the challenges in their place. I plan to work on that in 2020.

While CAH stepped back from newsletter communication for a while, it has been a good year of helping victims’ families as usual. We also had some successes in our DNA program and we will be able to expand that program in 2020.

One of the most difficult challenges for me and CAH was the gut punch all of California received when the new Governor Gavin Newsom, without hesitation, lied to all of us. During his campaign, he promised to follow the voice of the people. The people spoke when we voted time and again to keep the death penalty and we voted to expedite the process (which was the primary reason for exorbitant costs to taxpayers). He intentionally betrayed us within weeks of taking office placing a moratorium on all DP executions. He lied again when he promised to follow the voice of the people, who voted NO to state rent control. Yet he, contrary to his promise, now has mandated a state rent control. The increase in taxes placed on Californians is just another betrayal our citizens are struggling to handle. The list goes on.

Each and every day, California is being forced in the direction of criminal leniency; murderers, rapist, child molesters, etc., are being released back into our society to murder, rape and molest again.

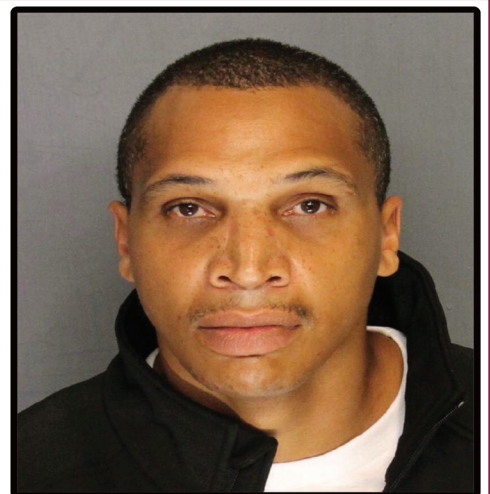

We are so happy to inform you that the Brighton, New York police department arrested and arraigned her husband, James Krauseneck for her 1982 ax murder. His trial is upcoming in June and they have charged him with second degree murder. I’ll also try to send some of the other information we have received from Cathy’s sister, Annette.

However, our conversations with law enforcement back then were simply “noted”; because they needed that “smoking gun”. We are so grateful Chief Henderson grabbed the reins of Cathleen’s unsolved homicide case and launched a new investigation. Imagine how many cases could be solved if there were more like him.

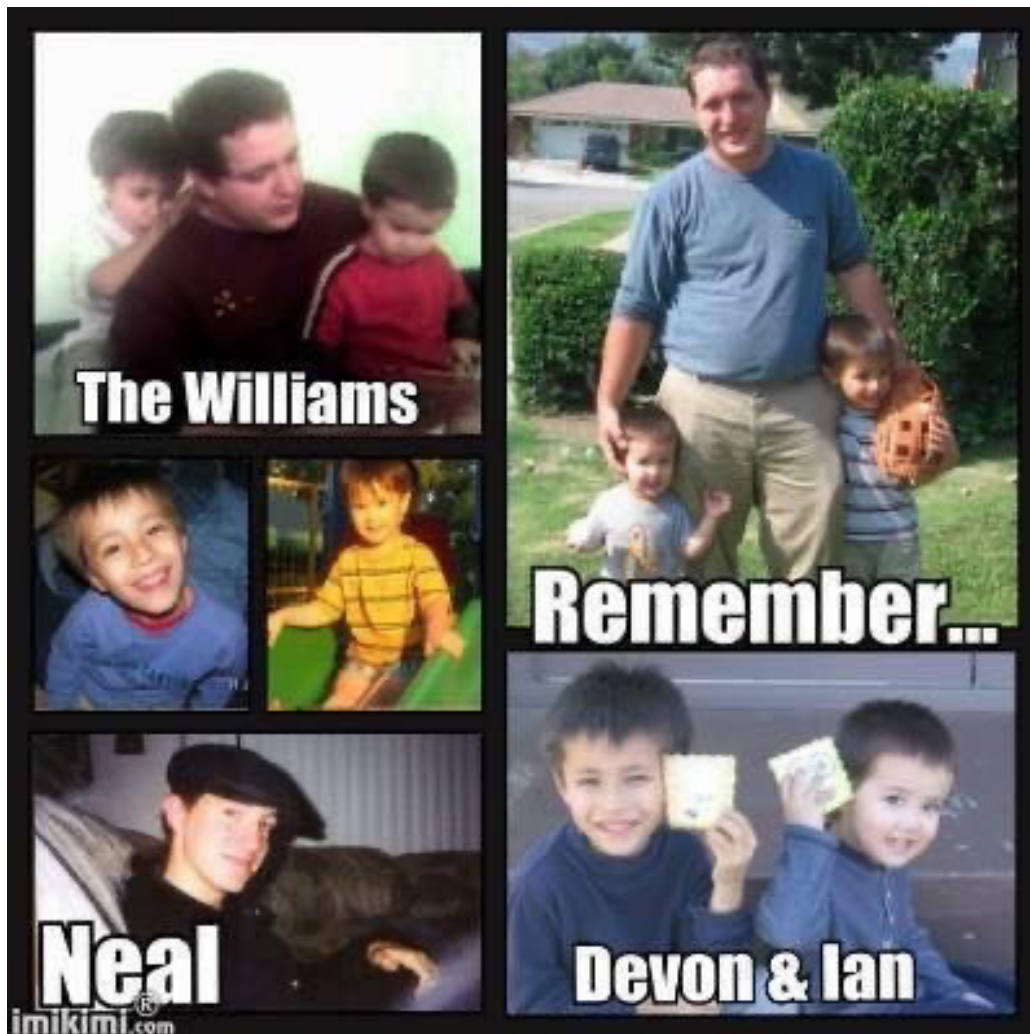
Holidays: The Dark Days

Those of us who have lost someone to murder are now part of a totally different society - a sub-culture if you're an anthropologist. We have crossed an emotional bridge. We look at others across a huge dark chasm. The things that we used to think of as important, like sales goals or workplace politics, sometimes seem silly to us. The people

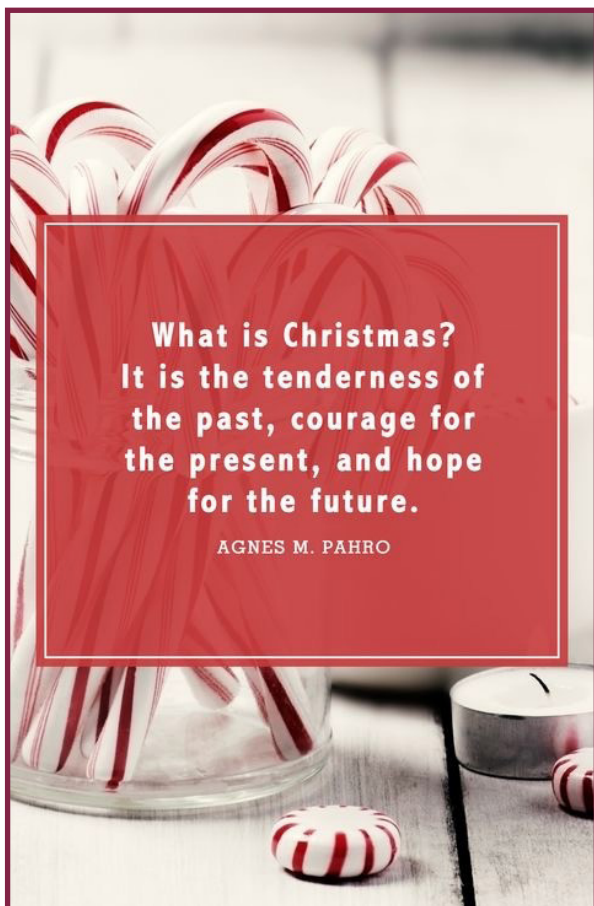

They want us to come back to the other side, the safe side, so they don't have to be reminded of that terrible dark canyon and the unknown land on the other side. Not going to happen. It's a one-way bridge. They don't understand that we live on this side now. We would willingly meet them on the bridge for a hug or cup of coffee. We would tell them about what life is like on the other side, and they would be able to see us much more clearly. They are afraid and only see

the darkness. They fear that somehow, we will grab them and pull them over with us if they come close. We are modern day lepers. How many times have you seen people you have known for years cross the street or reverse direction so that they don't have to talk to you? I sometimes want to hold up a sign that says, "murder isn't contagious!" I guess you can't really understand what it's like for us unless you join us. I wouldn't wish that on ANYBODY.
