# Eric Edward Velasquez

Over 31 years ago, just after midnight on Monday, March 7, 1994, Eric Edward Velasquez, 21, was killed instantly by a single, large-caliber round. According to autopsy results, the bullet entered Eric's right shoulder, pierced both lungs, his aorta, and exited through the left side of his back.

This is a graphic and tragic end to Eric's life. He was not associated with drugs or gang activity. He studied art at UCSB, played football in high school, worked tirelessly at multiple jobs, baby-sat his 10-year-old brother and often prepared family dinners.

Santa Paula police arrived at the scene in response to multiple reports of a single gunshot. There they found Eric lying dead under the carport of a small garden apartment complex at 720 N. Ojai Rd., directly adjacent to Mill Park. Although a Ventura resident, Eric was simply visiting an acquaintance whose mother and sister also lived in the multi-dwelling unit.

There are conflicting reports as to what happened in the hours prior to Eric's death. At the time, police reported to local news outlets that the murder could have been a "revenge slaying." In fact, officers responded to the same location at 10:30 p.m. regarding a quarrel between Eric and a "chunky guy" (and possibly others), over a previously vandalized car. Police broke up the disagreement and sent everyone on their way.

Then, just after midnight, Eric went out to the parking lot to return to his Ventura home... he never made it to his car.

His family is heartbroken. For 31+ years, Eric's mother has worked tirelessly to unravel the clues surrounding Eric's murder. She sadly admitted that simply

After answering his question, we invited him to our next meeting. This was in 2002, and the rest is history. He accepted the invite and never missed a meeting thereafter without good reason.

From that day forward, Chuck was one of the first to arrive for each meeting and religiously toted a box—that beautiful pink box full of the best donuts ever. Although he rarely would partake in these delicacies, the rest of us found ourselves looking forward to them. They became his trademark and he became an integral part of our

CAH organization. His stellar intelligence, sound/solid opinions, calm/cool demure were recognized and greatly appreciated by everyone. Chuck's brilliant sense of humor also deserves notable recognition. He always had a suggestion and if not a suggestion, there was always "have you heard this one". He had it all and we miss him.

During his recent Celebration of Life, I enjoyed listening to his family as they shared those special moments and memories of their beloved "Uncle Chuck" or "Uncle Chuckie". Interestingly, he was a bit of a daredevil; he liked fast cars and fast bikes. He was truly a self-made man full of life, love, a zest for life and not afraid to find adventure. Finally, their love for him was obvious and immeasurable. He made such a positive impact on their lives

knowing what happened that fateful night would ease her mind. "I know my prayers are getting to him. When you have a child die, part of you is gone, and the pain does not go away."

Although local law enforcement investigated several possible suspects, including the "chunky man" involved in the argument with Eric, no arrests have been made. Someone holds the key to this senseless murder, and it is time to do the right thing and come forward. The Santa Paula police need further information regarding the shooter, or someone who knows the shooter.

There is an active \$50,000 Governor's Reward Proclamation for anyone who can provide information leading to the arrest and conviction of Eric's killer.

# KNOW SOMETHING, SAY SOMETHING!

If you have any information relating to the unsolved homicide of Eric Velasquez there are three ways to submit an anonymous tip through Crime Stoppers: 1) call the Crime Stoppers tip line at 800-222-8477; 2) visit P3Tips.com or download the P3Tips app; or 3) visit venturacountycrimestoppers. org and click on "Submit a Tip." Should your anonymous tip result in

a felony arrest, you may be eligible for a reward of up to \$1,000 through Crime Stoppers.

Your identity is always encrypted and anonymous. No personal information, phone number, e-mail, IP address or location is ever requested, saved, traced, tracked or monitored. It is not necessary to testify to receive a reward, and you remain 100% anonymous without fear of retaliation.



## Parole & Clemency Hearings

# These parole hearings are imminent. Send letters in support of these families today.

The family of Tristan Thomas Daily is requesting letters of opposition be sent to Governor Gavin Newsom. On March 26, 2025, the Board of Parole Hearings found convicted murderer Joseph Lee Daily suitable for parole. Dear Governor Newsom~

Please DO NOT grant a parole date to convicted murderer, Joseph Lee Daily. On May 5, 1995, Joseph Daily brutally and senselessly beat his own infant son, Tristan Thomas Daily, seven (7) weeks old. Little Tristan died a terribly slow and horrific death as the result of head trauma, when his father repeatedly

slammed his head against the wall. He then deserted Tristan's unconscious little body on the floor. A neighbor called 911 and when paramedics arrived, they discovered Joseph Daily had fled the family home. According to medical staff at Children's Hospital in San Diego, CA, the blows sustained by Tristan were equivalent to a fall from a three-story building. The baby's injuries consisted of multiple fractures; to include the skull, with severe head trauma and brain damage. Tristan remained in the hospital for five (5) days until he succumbed from his injuries on May 9, 1995.

Joseph Daily immediately fled the state, as the coward he is, and was harbored by his family until arrested and extradited back to California for trial. He was convicted of Second Degree Murder and Felony Assault Against a Child and was sentenced to 15 Years To Life. It was only during his first Parole Suitability Hearing in 2007, that this convicted murderer

admitted to being responsible for the death of his infant son; that Tristan was being "punished" for wetting on him during a diaper change.

On March 26, 2025, Tristan Daily's family received the worst news since the day he was murdered. The Board of Parole Hearings actually found this unstable, heartless sociopath suitable for parole. We are shocked and feel betrayed with this decision, given Joseph Daily's complete disregard for human life, lack of remorse and conscience for brutally beating and killing his own infant son. This senseless act of violence, in this murderer's own words, "a punishment", was a personal choice made by Joseph Lee Daily.

Tristan never had the opportunity to grow, thrive and enjoy life. His innocent seven (7) week-old life was brutally snuffed out by the hand of a man who chose brutal violence in lieu of nurturing love. Joseph Daily does not deserve a second chance or the privilege of freedom.

I respectfully request you review this matter and come to the same conclusion that Tristan Daily's family has maintained since his brutal and senseless murder. One cannot help but question, "What kind of a man could torture and then murder his own baby?" Anymore today, the only people serving life sentences are those who have lost loved ones to murder. Please deny parole to convicted murderer, Joseph Lee Daily, for the maximum time allowed by State of California law.

# AB 622— Bill for Early Release of Murderers?

Dear Friends.

AB 622 squeaked out of the Assembly Public Safety Committee with a bare minimum five votes. The other four are recorded as not voting, but in the California Legislature not voting is effectively the same as voting no. While it would have been better to kill it in committee, this minimum support for it on a committee stacked with soft-on-crime types does raise some hope that

we may have a chance to defeat it on the floor. We probably have a better shot in the Assembly than in the Senate.

## Ora Mae Knowell

JUNE 2, 1945-MARCH 31, 2025

It is with tremendous sadness to announce the passing of yet another cherished Citizens Against Homicide (CAH) Board Member. Gene and I met Ora over 20 years ago when we joined CAH. She had already been a long-time member of CAH and we were newbies looking for help with our family's double homicide case. There was an instant connection with Ora: she was lovely, warm, kind and welcoming—We were shocked to learn that Ora lost two sons to homicide. As time passed, we shared in a common goal—to assist countless families going through the same life-changing losses.

Ora was a beloved mother, grandmother, great-grandmother, great-great grandmother, and dedicated friend whose kindness and wisdom touched all who were lucky enough to





know her. She was a devoted mother to five children, three of whom survive her and proudly raised two grandchildren as her own. Her family brought her immense joy and pride and her love for them was immeasurable. She leaves behind a legacy of strength, love, unwavering and unconditional support.

I remember thinking back through the years how amazingly strong she was. After losing two sons, she had the

> fortitude to work through her tremendous grief by giving of herself to others.

Ora, (known as the "Neighborhood Grandmother") genuinely cared about children suffering the loss of parents by violence. In 2002, she founded the Fatherless Children Foundation: Backpack Giveaway. Each year she and her supporters would gather at 10th and Center in Oakland, CA to hand out backpacks to children in need. In an interview, she stated "I chose this location because so many young people were killed right there in that spot.

Children lost many loved ones there and I needed to do something to comfort these kids. There were so many kids suffering."

In 2005, while volunteering to teach sewing to a group of students at Millennium High School in Piedmont, she came up with an artwork idea—hence began her creation of quilts in honor of her two sons and then for families of

homicide victims. Her quilts were by far her most personal expression of her loss and those of other victims. They were displayed everywhere from the Capitol's Victim Rights Week to countless victim awareness conferences and rallies. Ora stated many times "If they don't have a voice, I want to be their voice. I want to speak with them (families) to let them know that somebody cares."

Ora was a recipient of the 2018 Bay Area Jefferson Award for Outstanding Public Service, an honor she wholeheartedly deserved.

The love and compassion in Ora's heart knew no boundaries. She cared deeply for families suffering the loss of loved ones to homicide and she will always be remembered for her tremendous outreach efforts.

Ora, my dear friend, rest easy knowing how many lives you touched. Thank you for making this world a better place for so many.

## **Dennis Palmer**

On March 18, 2025, Citizens Against Homicide Victim Advocates, Gene and Shellie Cervantes met with friends of homicide victim, Dennis Palmer at the CAH facilitated Reward For Information Billboard in Clements, CA. KCRA Channel 3 graciously accepted our invitation for an interview and TBD expose. A heartfelt "THANK YOU" to KCRA and OUTFRONT MEDIA for your help in publicly bringing forth unsolved homicide cases.

On August 3, 1987, Dennis Palmer (age 33) disappeared from his residence on Middle Bar Rd. in Jackson, CA. His body was discovered on August 20, 1987 in a mine shaft on his property. This case is solvable. There were suspects (one in possession of the victim's pickup), however, Amador County Sheriff's

Office needs further information/evidence to move forward with the arrest(s). Someone holds the key to this mystery, and our message is—After almost 38 years of remaining silent, it is time to do the right

thing—come forward. The Palmer family deserved answers; Dennis deserves justice!
