George R. "Smitty" Smith & Eva Thompson

Some may remember the heart wrenching unsolved homicides of George R. "Smitty" Smith and Eva Thompson. CAH featured their story (written by Granddaughter, JoAnn Holland) in our June 2003 newsletter and then updated in our October 2024 newsletter. I will recap a few excerpts in JoAnn's words:

"On Veteran's Day, November II, 199I, our lives changed forever. On that quiet afternoon, my dear 80-year-old grandmother, Eva Thompson and my wonderful 67-year-old stepfather, George "Smitty" Smith were brutally murdered in their home. My mother, Ann, and Smitty owned a well-known lunch/dinner restaurant in Prunedale, CA near Salinas and Monterey. The restaurant building also functioned as home for all three family members. The restaurant was closed on Veteran's Day, so my mother went out to do some shopping. While my mother was out, a murderer cut the screen in the back door and entered their home/restaurant. Smitty was sitting at his desk... my grandmother confined to her hospital bed in her room. The murderer approached Smitty from behind and slashed his throat; then went to my grandmother's bedroom and slashed her throat as she fought for her life. The primary suspect knew the layout of the building and the motive was robbery.

A Few Words From Jan

It was with tremendous heartache that I listened to the events surrounding the Annunciation Catholic Church shooting. My daughter, having been murdered, just as many of you also suffering the loss of murdered loved ones, news like this invariably strikes that sharp pain in your chest that lasts a lifetime. The pain does subside in time but can so easily be brought to the forefront of our hearts and minds.

When you think of those young people in the early chapters of their lives, in their holy place praying to God and sharing in His love—what an ironic place to be. My entire family shares their same religion. Thoughts of my grandchildren in exactly that same environment, brought chills along with the pain. Reflecting, I can remember when another school shooting prompted extreme security measures at my grandchildren's school. Side doors and gates were closed with one entrance where only students and parents were allowed on the school grounds.

Parents, whose children were spared, were not only praying words of gratitude and thanks—they were praying that God comfort those parents suffering the unimaginably painful loss of their children. If more parents brought their children to pray and teach their children the value of prayer then maybe together we could all make the world a better place.

Then, of course, make way for the "Gun Control" narrative—the next "answer" by those who criticize prayer! To actually come out with accusations such as "the fault lies with everyone who owns a gun" is the most ridiculous, unethical path

Fresno, of two counts of first-degree murder for killing George Smith and Eva Thompson at The Smith's restaurant in Prunedale on November II, 1991. The jury found true special-circumstance allegations that Bastian murdered Mr. Smith and Ms. Thompson during the commission of a burglary and that he committed multiple murders in the first degree. They further found true allegations that he personally used a knife to kill both victims.

George Smith, then age 67, and his wife Anna Smith owned and lived at The Smith's restaurant, which was located on El Camino Real North in Prunedale in 1991. Eva Thompson, then age 79, was Anna Smith's mother and also lived with the couple.

On November II, 1991, Anna Smith returned home from running errands

and discovered that her husband and mother had been brutally murdered. George Smith had been stabbed II times with a kitchen knife. Eva Thompson, who was physically disabled and unable to walk, was found slain in her hospital-style bed. She was beaten, strangled, and her throat slit with the same knife used to kill her son-in-law. George Smith's bedroom was ransacked and cash stolen from it. The knife was recovered in a laundry hamper in the restaurant hallway.

Bastian, then age 52, was a former employee of The Smith's restaurant, but he claimed to have not been at the business for more than a year prior to the murders. A pair of shoes provided to investigators by his then-girlfriend was determined to have left shoe impressions in the backyard of the restaurant, near the door where the killer made entry. He was considered

a suspect in the initial investigation, though no charges were filed at that time. The Monterey County Sheriff's Office diligently pursued the case for decades and continued to submit and re-submit items of evidence in the case for newer and more sophisticated DNA testing.

In 2024 and 2025, additional DNA testing provided very strong support that Bastian was a contributor to DNA mixtures on the inside of the shoes provided to investigators by his girlfriend, the handle of the knife, and the nightshirt worn by Eva Thompson that was collected at her autopsy.

The Honorable Andrew G. Liu presided over the 10-day jury trial. Bastian is scheduled to be sentenced on September 24, 2025. He faces a prison sentence of life without the possibility of parole.

used by social media to promote fear and violence. The gun did not go off by itself. There was a human, an evil human that held that gun and pulled the trigger. That evil human violated the gift that God gave him of free will and he chose to take the lives of innocent children who believed in and loved their God. Today's media sensationalize and make excuses for these individuals, completely sidelining the victims. These evil individuals need to be held accountable for their actions. Strong consequences, accountability,

no excuses and never mention their miserable names again.

All my life I have leaned on the power of prayer. Not to change life events, but to lean on this power greater than me. On many occasions, I have shared with you my belief that God has a large tapestry, that we are all beautiful strands in this tapestry and that one day, when we reach our place in heaven with God, this beautiful tapestry will divulge what our true path was. Now, after 41 years of my daughter's unsolved murder, I look back over those years and genuinely believe the path God chose for me was to help other families through the same pain of loss. Over these years I believe I,

(and all those working with CAH) have helped many hundreds of families. Each in a different and special way.

Today, my prayers continue for all the families of the Annunciation Catholic Church School, as their lives have been changed forever. I pray that God makes His presence known to those suffering such tremendous loss and to those suffering the horrific violence of that day. I pray they find solace with thoughts of God's beautiful Tapestry; the path He has created for each of us to make the world a better and more loving place to live.

Corcoran Mom Pushes for Adult Charges for Violent Juvenile Offenders

CORCORAN, Calif. (FOX26)—It's been five months since 17-year-old Lorenso Sanchez of Corcoran was killed outside the Hanford Mall.

The suspect in the fatal stabbing is just 15 years old.

Now, Lorenso's family is channeling their grief into action, calling for changes to California's juvenile justice laws.

The Sanchez family is gathering signatures for a petition that seeks to let juveniles face adult charges for violent offenses.

They are advocating for changes to Proposition 57, the 2016 law that transferred the authority to decide if minors should be tried as adults from prosecutors to juvenile court judges.

Lorenso's mother, Julia Sanchez, who says the pain of losing her son has only intensified.

"It's very hard. It's getting harder. Everywhere I go, I think of my son. It hasn't gotten any easier at all," she said.




Despite the heartbreak, Sanchez is determined to seek justice not just for her son, but to prevent future tragedies.

I feel like if we don't change this, they're going to keep doing it. How many more of our kids do we have to lose?

According to Hanford police, Lorenso was fatally stabbed on April 26.

Because the suspect is under 16, Kings County prosecutors are legally barred from charging him as an adult under current law. The teen has pleaded not guilty.

Julia Sanchez says she still has unanswered questions.



Now, she's hoping to turn her pain into purpose with a growing movement behind "Lorenso's Law."

Her petition has already garnered more than 9,000 signatures.

The goal is to gather as many signatures as possible to ensure it reaches Assembly member Alexandra Macedo. Macedo represents California's 33rd Assembly District, which includes Kings County and the City of Corcoran.

Kings County Supervisor Richard Valle is also supporting the Sanchez family's efforts.

"No one needs condolences. No one needs sympathy. We need action," Valle said.

Julia says the push for change is not just about her son, it's about preventing another family from experiencing the same pain.

We don't want this to happen to anybody else. My son had so much potential. He didn't deserve this. No other kid deserves it.

I don't want his name to be forgotten. I don't want him to be just a moment of light that suddenly fades away.



Reform Prop 57: Demand Justice for Victims and Pass Lorenso's Law

THE ISSUE

Justice for Lorenso, Jacob, and Caleb—Reform Prop 57 & Pass Lorenso's Law

On April 26, 2025, 17-year-old Lorenso was taken from us—killed in a violent crime while walking away from a group of teens aged 11–15. The 15-year-old attacker stabbed him in the neck.

His mother, shopping inside the mall, was called outside—only to find her son lifeless. Any mother's worst nightmare.

Lorenso was a talented athlete with big dreams to play football for Fresno State. His life was full of potential. Our community is devastated, and we are standing together to bring justice for Lorenso.

But this fight is not just for him.

Jacob Munoz and Caleb James Quick were also taken from their families in separate violent incidents—each case ending with the offender shielded by California's Proposition 57. These young men should still be here. Instead, their families are left grieving while those responsible face minimal consequences.

WHAT IS PROP 57 AND WHY IT'S FAILING

Passed in 2016, Proposition 57 makes it much harder to try juveniles as adults—even for murder, sexual

assault, armed robbery, and other violent crimes.

While meant to promote rehabilitation, it has instead created a loophole where age shields accountability.

Families are left grieving. Victims are forgotten. Communities are unsafe.

WHAT WE'RE ASKING FOR

In honor of Lorenso, Jacob, and Caleb, we demand that California lawmakers reform Proposition 57 by passing Lorenso's Law to:

- Allow violent juvenile offenders to be tried as adults when appropriate
- Ensure serious crimes have serious consequences—regardless of age
- Restore justice, safety, and fairness to California communities

If you are old enough to commit a violent crime, you are old enough to face the consequences.

WHY THIS MATTERS

Lorenso's, Jacob's, and Caleb's stories are not isolated. Too many families have lost loved ones to violent crimes committed by minors who face no meaningful punishment. Prop 57 has become a barrier to justice.

We cannot keep ignoring victims.

We cannot keep giving violent offenders a free pass.

We must act now.

Were you the victim of a crime and the court ordered you restitution? The California Department of Corrections and Rehabilitation may have collected money for you. Contact the Office of Victim and Survivor Rights and Services to inquire if you have unclaimed money from a direct order of restitution.
